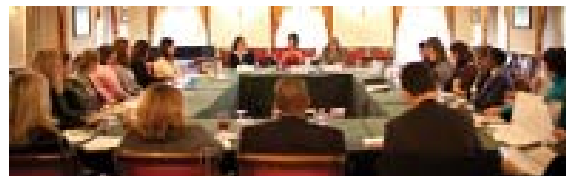
### 1099-INT and 1098 forms
